## 2023.2.1.16: Streamlining Observational Visits

## **Evidence Overview**

The information provided outlines a decision to streamline and enhance the efficiency of observational visits for students in methodology courses, including the EDES 4006 course. This decision is based on feedback from stakeholders in the Puerto Rico Department of Education and aligns with CAEP Standard 2, which emphasizes co-construction and collaboration. The key change involves compiling a consolidated list of students at the beginning of each semester, which includes detailed information such as student names, ID numbers, contact details, designated schools, and teachers to be observed. This list will be sent to school directors for approval before the observational visits begin, ensuring all necessary preparations are made in advance. This measure aims to prevent delays, improve coordination with partner schools, and enhance the support provided to students during their observations. The administrative office will handle all related communications going forward, and any inquiries should be directed to them. This proactive approach demonstrates a commitment to improving educational processes and supporting student learning experiences effectively.
