REQUIREMENTS (NORMS AND REGULATIONS OF THE COURSE):

All students are expected to:

- Complete all lessons.
- Do all assigned readings and related homework in preparation for class. Students are responsible for copying the educational material send through the uprm email systems. All the students must bring this material to class.
- Come to class prepared to discuss, analyze, apply, summarize and participate with peers.
- Type all papers in APA format (6th ed.).
- Fulfill all requirements to receive credit for the course. Work required is expected on the assigned date unless there are unavoidable changes in the schedule of classes. Planned assignment or written work must be handed in on the assigned date. Five points will be deducted for each day of delay including weekends and holiday. Students will have to notify professor *IN ADVANCE* if for any reason a paper cannot be handed in on time for a possible agreement upon this matter (only under extraneous circumstances). No course requirement will be accepted through e-mail or fax.
- Students who schedule an office visit with the Professor are expected to attend on time or call to excuse themselves for the expected tardiness or absenteeism to the meeting.
- All students are expected to maintain a professional attitude and demonstrate ethical standards in their interpersonal relationships in the classroom.
- Cell phones, beepers, radios, types and other audio or video equipment must be turned off while in class, failure to do so will jeopardize the grade. For every interruption to the class caused by these equipments -.3 points will be subtracted to the class attendance grade.

- Four scheduled visit to the professor's office to discuss the progress of the research proposal **are required**. Failure to comply will be reflected in the class "Office visits" grade. The number of visits made by the student will be divided by 4 and multiply by 100 to obtain a percentage.
- Absenteeism will affect the final grade, according to the following scale: Absence = -1, Excused Absence = -.7, Tardiness = -.5, cell phone, beepers or other interruptions = -.3. Three (3) tardiness to conferences will be equivalent to one absence.
- Evaluation criteria sheets provided the first day of class must be included as part of each and every paper, assignment or presentation given or handed in (at the moment they are being handed in). Failure to do so will imply a -5 point deduction from the final grade of the class requirements.
- Plagiarism will not be tolerated. Partial or complete reproduction of copyrighted material or material from papers presented by other professional or students will be severely penalized. Students involved in this activity will receive a final grade 0.

CAMPUS POLICIES:

- A. *CLASS ATTENDANCE*: Class attendance is compulsory. The University of Puerto Rico, Mayagüez Campus, reserves the right to deal with individual cases of non-attendance at any time. Professors are expected to record the absences of their students. Frequent absences affect the final grade of a student, and may even result in the total loss of his/her credits. - C. *FINAL EXAMINATIONS:* Final written examinations must be given in all courses unless, in the judgment of the Dean, the nature of the subject makes in impracticable. The professor evaluates the results of the final examination in relation to other class work and used the method he or she deems most appropriate to classify the work of students, provided that he or she is able present sufficient evidence of an objective basis for the grades given. Final examinations scheduled by arrangement must be given during the examination period prescribed in the Academic Calendar including Saturdays and Sundays. No change in the date assigned for a final examination may be made without the written authorization of the respective Dean of the College concerned, and the Registrar. - **D.** *PARTIAL WITHDRAWALS:* A student may withdraw from individual courses at any time during the term, but before the deadline established in the Academic Calendar. (See Undergraduate Catalogue).

GRADING SYSTEM:

The grades at the Mayagüez Campus are as follows: A, excellent (4.0); B, good (3.0); C, satisfactory (2.0); D, passing, but deficient (1.0); F, failure (0); P, passing; W, authorized withdrawal. In the case of thesis or research in progress, the grades S (Satisfactory) and NS (Not Satisfactory) and NS (Not Satisfactory) will be used, but like the grade P, will not be considered in computing the grade point average. The same rule may apply in some seminars. "C" is the minimum grade for passing any graduate and major courses in the Colleges of Business Administration, Engineering, and in the major courses in the Departments of Nursing, Mathematics, and Physical Education. The minimum grade for passing other undergraduate course is "D". (See Undergraduate Catalogue).
