### 2. Course Description:

This is an introduction to the new, rapidly evolving, and interdisciplinary field of Earth System Science. This course emphasizes the ideas of Earth as a planet within the solar system; the interactions among the components of the geosphere, hydrosphere, atmosphere, and biosphere; and global changes. Studying Earth as a system is accomplished by the analysis of remote sensing data. Images acquired by airborne and spaceborne sensors are used throughout the course.

### 3. Course Objectives:

- A. Establish the relationship between the components of the Earth System.
- B. Present the latest technology for understanding the Earth at global scale.
- C. Provide a large-scale perspective of the Earth processes.
