Also, provide any documentation, which supports your request. Your letter may include any changes (i.e. natural disasters, changes in national economy) in your country, which affect you or your family's ability to obtain the funding expected.

 \Box 2. Complete the ISFAA Form: Complete the entire application and mail or drop it off in person to the Office of Graduate Studies. Do not leave any blanks. Enter "N/A" (for not applicable) if a question does not apply to you.

□ 3. Submit Bank Statement(s): Student (or sponsor) – provide 12 months' worth of ALL checking and savings accounts
